The Board has determined that Metropolis' in-house Request for Action (RFA) System © is exactly what Maryland Farms Condominium may need to address community requirements, and also allow a forum for community members to express their observations.



The RFA system provides an amazing resource for scheduling, to help ensure that things are done in a timely manner, as well as providing a format for thorough documentation of actions taken, and information from calls, emails, and faxes, tying all aspects of a particular issue into one file holistically. Through utilizing this system, the community as a whole will benefit, as information can be gathered and forwarded to the Board of Directors for decisions.

# So, What's an RFA?



Metropolis created its own software for tracking and managing the actions which are generated during the management of a community. Our Request For Action System © allows us to address and report on community matters. When you call our office, you'll be given an RFA Number. That number tracks the unique issue which you have brought up. All information related to that RFA - conversations, documents, emails, phone messages - are attached to that RFA. If the person you first talked to isn't available the next day - well, any one of the Metropolis staff can review and address next steps with you. An RFA may last for a

day - maybe you want to know your account balance - or may last for years - such as the RFAs we use to manage the Association's budget cycle. Either way, Metropolis can keep the Board in touch with the community!

# Don't Forget the Condo Fee!



Metropolis has been working with the Board and previous management in order to provide a smooth transition. In the next week, you should receive your coupon book for the payment of your association fees starting February 2015. The Association's transition to Metropolis means some new options for paying your condominium assessment, as the Association will now have an account with BB&T. One of these is to pay your

assessments online! The coupon booklet from BB&T will have instructions on how to set up an online account. If you wish to pay with a credit card, you may do so as well, but there is a fee paid directly to BB&T for doing so. And of course, by working with a local bank, you may simply bring your payment and coupon to any BB&T branch. You can also choose to pay your assessment by check or money order, or have your bank pay through its bill payer service. If you choose any of the latter three options, please make your check or money order payable to Maryland Farms Condominium and ensure that your account number is printed or written on the front of your check. The account number will be within the coupon booklet. The mailing address is:

During the month of January, you may drop off your payment to the Maryland Farms office if you wish during the transition. If you have already paid Site Realty for the month of January, their records should reflect the payment; but we ask that you please keep a copy of your payment. If you have Direct Deposit or other auto payments, please remember to <u>discontinue them!</u> Due to the transitional period, we will not be charging late fees for the month of January. And remember, there is no increase in assessment fees for 2015!
